

Family Carers Ireland National Christmas Raffle 2025 – Terms and Conditions

The Promoter:

By entering this Raffle all entrants agree to be bound by these terms and conditions and any other conditions in the messaging or promotions of this Raffle (which may be amended at any time by Family Carers Ireland). Any entries not complying with these terms and conditions will not be valid.

- All raffle tickets must be received by the Promoter no later than midnight on the Closing Date. Any tickets received after this date will be disqualified.

To enter the raffle:

- On purchase of an online ticket for the raffle draw, all purchasers of tickets are automatically entered.

If due to unavailability of a particular prize, beyond the Promoter's control, the Promoter and sponsor reserve the right to substitute a particular prize for another prize of similar value.

- The winner(s) will be drawn randomly on the iDonate platform the day after the closing date which is Thursday 18th December and will be supervised by an independent scrutineer.

- The winners will be notified within 5 working days of the closing date either by email or telephone.
- In the event that we cannot contact any of the winners within 28 calendar days after the draw, another name will be drawn and a new prize-winner will be declared.
- The winner's name will be announced on the Family Carers Ireland social media accounts and newsletter.
- By entering the draw, winners confirm their agreement to take part in any associated publicity.
